Governance of the Third Mission at a Multi-Campus University Benjamin Robert Schiller 2022-01-12 This book appeals to higher education scholars from various disciplines and practitioners looking for an overview and in-depth insight into cooperative study programs (CSPs). The CSPs combine elements of higher education with elements of professional work and illustrate how a teaching-related third mission achieves a socioeconomic contribution through its underlying stakeholder interactions. In Germany, CSPs are a growing phenomenon and, at the same time, a niche in higher education with approximately 100,000 students. Higher education scholars identified CSPs a challenge to higher education governance despite the simultaneous lack of empirical data. In this vein, this book pursues the question of how stakeholders influence the governance of the third mission in the case of CSPs. The study in this book refers to the "prime" example of CSPs at a German university of applied sciences—the Baden-Wuerttemberg Cooperative State University. The analysis revealed that four stakeholder groups are salient and influence the governance of the CSPs. These include professors, industry representatives, students, and representatives of government and higher education policy.

our subsistence and survival. In the food domain, cereal and legume grains occupy the front line, whereas, horticultural crops have occupied the second line of defense. For healthy diet cereals and legumes provide us with carbohydrates and protein, whereas, fruits and vegetables provide us minerals and vitamins. Both macro- and micro- nutrients are essential for human growth and development. The fruits and vegetables are the major source of micro-nutrients. It is estimated that up to 2.7 million lives could potentially be saved each year if fruit and vegetable production was sufficiently increased. Both at national and international levels, food and agriculture/horticulture development plans and estimates are basically developed, framed and implemented, and narrowed down to cereal production. In the present context of attaining nutrition security, this mode of thinking on 'food' needs to be changed to 'nutrients', which will include necessarily all those crops including fruit and vegetables which provide all macro- and micro-nutrients to ensure balanced nutrition needed for good human health. The present publication has attempted to reflect and discuss the above views and ideas on the subject of sustainable horticulture development and nutrition security in nine chapters with 32 articles by 32 authors.

Critical analysis of what we know - and do not know - about women in the Arab region is needed to support social change. But how is knowledge on women and gender produced in the region? How does this change when it is undertaken by Arab women researchers? Through a critical examination of local fieldwork experiences, the contributors of the volume - who are Arab women researchers themselves - answer these questions. The book examines the specific structural conditions that shape people's lives in the Arab region, from the effects of imperialism, settler colonialism and the neo-liberalization of economies, to racial capitalism, securitization, and embedded patriarchal ideologies and structures. The authors assess the implications of these different dynamics on undertaking research and also examine their own daily lives, the lives of their interlocutors, and the practices of their field. In doing so, they are able to escape hegemonic

approaches and frameworks to the study of gender and to instead theorize from the local context to produce knowledge as they see it. This 'engaged gender research' challenges dominant discourses in academia, rejects the presumptions of 'Arab exceptionalism', and challenges liberal feminisms. It devises a new way of undertaking research on gender in the region to lay the foundation for a more just tomorrow. Covering Morocco, Tunisia, Palestine, Jordan, Syria, Iraq and the Arab Gulf, the book argues that an engaged gender research - which is feminist and critically analyses the historical, political, economic and social contexts of the research topic first - will transform how we understand women and gender, and the Arab World.

Empowering smallholder farmers' organizations through non-public extension service providers: A case study and lessons from Mozambique Gêmo, Hélder R. 2019-02-21 The role and impact of non-state extension services providers have not been studied adequately. In this paper, we assess the performance of the non-State

extension service provision through farmers organization (FOs) in Mozambique. Using participating methods, focused group discussions, and key informant interviews, we provide an assessment of extension services provision to FOs. The result indicates only 3% of the 1264 surveyed FOs were categorized as "type A", the highest FOs rating scale used by services providers (SPs) in the three regions of the country. Effective monitoring and evaluation (regular, analytical, participatory) at field level and close working interaction between the Public Agricultural Extension Services (PAES) and the SPs were of paramount importance to track the progress made in empowering the FOs. SPs' pro-activeness and competence were critical factors to adequately address the various training needs of the different categories of FOs and local services providers. SPs' financial autonomy was key to compensate for the delays in the disbursements by the PAES. The selection criteria for the participating farmers (trainees) from targeted FOs makes a difference. Younger and more literate farmers (including women) have shown greater motivation and engagement in the training sessions. Outsourcing can be a valuable alternative for the provision of extension services if it targets specific intervention areas (for example, training for FOs), a limited number of activities, well-defined deliverables (including quality and sustainability issues) and timelines. Post-training (and post-project) actions at the policy level and extension services providers are required to contribute to the sustainability of the investment made. Based on these findings, the paper documents several operational lessons from the implementation of the program.
